Provide Feedback on LCAP/SPSA to Support English Learner Students</p> <p>Admin Jauregui reviewed the LCAP and SPSA slides with attendees and briefly explained both plans and the varying components within each plan. Admin Jauregui and L. Clark asked the members a few questions related to LCAP & SPSA and took note of the feedback provided by members.</p> <p>O. Rivera said that she is very grateful for the one. Program and couldn't think of anything to improve the LCAP or SPSA. O. Rivera did say that she believes more opportunities for EL students to speak, read, and write in English during the school day would be beneficial.</p> <p>M. Ambriz, was also very positive in her thoughts on how the program is run and didn't have much feedback toward plans other than there should be more parents at decision-making meetings.
