I. CALL TO ORDER:

President Vogel called the meeting to order at 5:30 p.m. County Committee member Gebhardt led the Pledge of Allegiance.

- II. ADDITIONS TO THE AGENDA: There were no additions to the agenda.
- III. COMMENTS: Tracy Unified School District Governing Board President Steven Abercrombie commented "I understand this is a done deal and it is out of the control of your committee to change it. The elections for the Board of Trustees for Tracy Unified School District are now going to be done via areas. The intent of this change is to try and make sure there is for equal representation throughout the school district. However, there are some flaws and issues with new process. First, there could be a time when no one runs for the board from an area. I have been told if no one runs then the Board shall appoint someone. That works if someone from the area applies. What happens if no one applies? Please don't say 'Well that will never happen'. There was a time when people think someone would walk on the moon, run a sub four-minute mile or the Cubs would win another World Series. I have also witnessed representatives only concern themselves with their area and not what is best for the district. They have stated I only need to keep the people who elected me happy. Ms. Parks reviewed the process that the Tracy Unified School District Governing Board underwent in selecting the trustee areas and alternate method of election, and noted that six Board meetings were held, five of which were public hearings, to provide opportunity for public input and discussion. During the public hearings, there was only one comment from the public: however, there were several community members present.

The County Committee reviewed the resolution and map exhibit, which included demographic variations of the proposed areas, adopted by the Tracy Unified School District Governing Board. There were no additional comments from the members of the audience.

President Vogel noted his appreciation for the thorough and extensive work of the Tracy Unified School District Governing Board on behalf of the County Committee and closed the public hearing at 5:46 p.m.
