Smarter Balanced Summative Assessments

The Smarter Balanced Performance Tasks Classroom Activity assignments are now available on the [CAASPP Web site](#). Also available are the Smarter Balanced Summative Test Blueprints, which are located on the [CDE Smarter Balanced Summative Assessments Web page](#). These blueprints describe the content of the English language arts/literacy and mathematics Summative Assessments and how that content will be assessed to reflect the expectations of the Common Core State Standards (CCSS).

Alternate Assessment Field Test

The California Alternate Assessment (CAA) Field Test begins April 15 and concludes June 10, 2015. The Field Test includes English language arts/literacy and mathematics for grades three through eight and grade eleven. Each student will take fifteen items per content area for a total of thirty items. The CAA is a one-on-one, computer-based assessment and is not computer adaptive. Student information will be uploaded into the Test Operation Management System (TOMS) like Smarter Balanced and the Individual Student Assessment Performance Profile (ISAPP) will need to be completed to reflect a student's individualized education program (IEP) accommodations and designated supports.
