### I. CALL TO ORDER:

President Sorgent called the meeting to order at 12:00 p.m. Greater Valley Conservation Corps Director Nick Mueller, led the Pledge of Allegiance.

II. ADDITIONS TO THE AGENDA: There were no additions to the agenda.

### III. COMMENTS:

YMCA Camp Jones Gulch Executive Director, Andrew Boyd-Goodrich, introduced himself and offered his appreciation for the ongoing collaboration and partnership with the San Joaquin County Office of Education (SJCOE) in regard to the operations of the San Joaquin County Outdoor Education program. He invited Board members to visit the camp to view the impact on youth through the educational endeavors provided at the camp.

IV. RECOGNITION: Superintendent Mousalimas and the Board recognized students and teachers from Venture Academy Family of Schools who participated in the Hamilton Education Program in Southern California. The students performed the selection they wrote and produced for the event.

### V. ITEMS SCHEDULED FOR INFORMATION:

- 1. Williams Uniform Complaints Quarterly Report: Superintendent Mousalimas presented the quarterly report that indicates there were no complaints received regarding the schools and programs operated by SJCOE between mid-July and mid-October.
- 2. Williams Settlement Annual Report: Superintendent Mousalimas presented and reviewed the findings from the mandated Williams Settlement visits and review of Decile 1 3 schools in San Joaquin County. Assistant Superintendent Jane Steinkamp provided the background in terms of the lawsuit that mandates this annual report. She explained that the governing boards of each of the school districts that were visited were also presented with the findings specific to their school sites at a public meeting and that each member of the governing board had received a copy of the report. The Board asked questions regarding the process for remedy of the situations discovered during the school site visits. Ms. Steinkamp explained that, with the exception of emergency situations, the school districts are relied upon to address the items and there is no requirement for the county office to continue to monitor beyond the initial visit.
- 3. Dashboard Report: County Operated Schools and Programs Division Director Sean Morrill, presented the Fall 2017 local indicators for SJCOE. He explained that the California Department of Education has identified 10 priority areas to be included in a Local Education Agency's (LEA) Local Control Accountability Plan and that data is not accessible at the state level in some of those areas. As a result, an LEA is required to provide those local indicators as a Dashboard Report. Mr. Morrill reported on the items germane to county offices of education, which included the Williams Settlement requirements, parent engagement, school climate, and support for foster youth and expelled students.

Superintendent Mousalimas added that the online Dashboard Report was developed by the Center for Educational Development and Research (CEDR) Department of SJCOE.
