3. TEAM Charter School Renewal Charter Petition and Resolution #20-21-15 — Resolution Conditionally Approving the TEAM Charter School Renewal Charter Petition: Assistant Superintendent Janine Kaeslin reported that a committee of San Joaquin County Office of Education (SJCOE) staff reviewed the petition appeal according to Assembly Bill 1505 and

Education Code. In accordance with Education Code § 47605(b), the San Joaquin County Office of Education posted the staff recommendation to conditionally approve the TEAM Charter School Renewal Charter Petition on April 6, 2021. Ms. Kaeslin introduced Executive Director and Co-Founder of TEAM Charter, Debbie Vallejo.

Ms. Vallejo shared a PowerPoint presentation before the Board. The presentation provided an overview of TEAM Charter, enrollment, grade levels, locations, and student populations. Ms. Vallejo also stated that TEAM Charter's audits have remained clear from findings by three different auditors and that budgets are managed effectively with a strong cash reserve that enables investment in solid academic programs. She indicated that TEAM Charter has reviewed and understands the staff recommendations and findings to conditionally approve the charter renewal and stated this is an opportunity to improve and strengthen their program.

Public comments submitted electronically were read into the minutes:

"Dear Trustee and Superintendent Mousalimas: I am writing you in regards to an item that is on today's agenda under section V. Item 3. for your consideration. I am very concerned with the recommendation to approve TEAM Charters 5-year renewal. During my short tenure at SUSD, I have found many inconsistencies as they related to Charter schools and the processes that has been used for their approval. The fact that your staff has also pointed out the concerns with the schools progress should be enough for you to deny their renewal. Furthermore, assuming oversite of a Charter school that is under our jurisdiction is bad practice and sets the wrong precedent. On behalf of the SUSD Board, we ask that you support their decision and vote no. Sincerely, John Ramirez, Jr., Interim Superintendent, Stockton Unified School District."

"Grand Risings Trustee Vigil, As a community member and constituent I have some serious concerns with regard to your vote on the Team Charter School agenda item today. I know that you all are award of the SUSD Board of Trustees vote on this matter and have addressed some of the concerns that we had with our staff recommendation. As a New Board member I am still learning Process but the acceptance of Team Charter as is represents an inconsistency with our values and needs in supporting our community. The lack of planning, implementation and statistical achievements does not reflect the culture that we are hoping to build and implore the board as a whole to take additional time to review the application in order to ensure that this does not pass a politically motivated agenda item in reaction to rhetoric that has been lobbied in public. Now more than ever we as a community expect decisions based in sound reasoning and with our community's best interest in mind. I hope that you all take the time to review and bring this item back if necessary with additional information and transparency. The decision affects over 500 of our San Joaquin County Students and families. Thank you for your time and due diligence in this matter. -Ray Zulueta Jr"

"Honorable San Joaquin County Office of Education Trustees; Today you are voting on Team Charter. Your current County Superintendent is reluctantly recommending approval with strict conditions. The Stockton Unified School Board voted to deny approval; although the previous administration recommended approval. There is obviously a reason for the denial. Attached is the comprehensive report produced by City of Stockton Vice Mayor Christina Fugazi. It is very well written. This organization is failing their students and yet their administration salaries are way too high. We realize that County School Board Trustees often vote with the recommendations of their staff; however you are probably not aware that there is a current Grand Jury investigating Charter Schools previously approved by SUSD and their financial relationship between Reinvent Stockton, Former Mayor Michael Tubbs, Lange Luntao, and some charter schools illegal involvement with local politics and elections. Many former SUSD trustees were employed by some of these same local Charter Schools. Your outgoing Superintendent and your Interim Superintendent does not have this information. Approval of Charter Schools has become extremely political and \$480,000 was raised by the "City Fund" and spent by political henchmen and "families for a better school board" to recall and overthrow the current SUSD Board and replace them with individuals who will do what they are told and approve new and existing charters. You can check the 460's for yourself. If you have to "pull this item" today as you do more research then please do it or just vote it down and let the state deal with it. Please send a San Joaquin County Board of Education

message that you wan the "Politics" out of our children's education and schools. It's a HUGE MISTAKE if you approve this even with conditions and probation. It would also be a slap in the face to the SUSD Board. Ask yourself this.....who spends nearly \$500,00 on local school board races? What would they want? Why would Team Charter be so important to them? Do they care about the students or the money? Don't be fooled by some of the letters of support. Some of the elected leaders just signed the letter their staff typed up without even knowing the issues. If you approve this today and something happens controversial with Team Charter then who is left holding the bag with responsibility? Not your superintendent by you the Trustees are responsible. We are sure that the Record and 209 times is about to do a story. Don't get caught up in this mess. You are the boss! Please make the right decision. -Stacey Arroyo"
