I. CALL TO ORDER:

President Vogel called the meeting to order at 12:00 p.m. Board member Gebhardt led the Pledge of Allegiance.

- II. ADDITIONS TO THE AGENDA: There were no additions to the agenda.
- III. COMMENTS: There were no comments from the audience.
- IV. RECOGNITION: San Joaquin County Office of Education (SJCOE) staff from County Operated Schools and Programs (COSP) and Code Stack Academy presented a deserving student with a scholarship that provides half the tuition needed to attend Code Stack Academy. Center for Educational Development and Research Division Director Johnny Arguelles explained that coding is currently a major career path and students who participate can catapult to a successful career upon completion of the academy. COSP administrator, Lucas Homdus provided background information regarding this student who has shown the necessary drive and outlook to complete his education through alternative education programs.

## V. ITEMS SCHEDULED FOR INFOMRATION:

- 1. Williams Uniform Complaints Quarterly Report: Superintendent Mousalimas presented the quarterly report that indicates there were no uniform complaints filed regarding the schools and programs operated by the San Joaquin County Office of Education between mid-July and mid-October.
- 2. Williams Settlement Annual Report: Superintendent Mousalimas presented the findings from the mandated Williams settlement visits and review of Decile 1 3 schools in San Joaquin County reporting that each school district governing board also receives this information and reviews it at their individual governing board meeting. Williams Act Coordinator, Lisa Neugebauer reported that this is the seventh year of visits to these schools and there were no major deficiencies found, adding that if a major issue is found she contacts the head of maintenance of that district and said issue is quickly remedied. There was a brief discussion regarding the mandate of visiting the same school sites until a new mechanism to evaluate which schools are in the lowest deciles can be developed by the state.
- Dashboard Report: COSP Division Director, Sean Morrill, presented the California Dashboard Local Educational Agency (LEA) Local Indicators for SJCOE schools. Mr. Morrill said that this report identifies the approved standards and self-reflection tools that an LEA uses to report its progress on the ten local indicator priorities that include the Williams settlement requirements of appropriately assigned teachers, access to curriculum-aligned instructional materials, and safe, clean, and functional school facilities; the implementation of state academic standards; parent and family engagement; school climate; access to a broad course of study; coordination of services for expelled students; and coordination of services to foster youth. Mr. Morrill reported that there has been progress made in each area. He noted his appreciation for the guidance and support from COSP staff who work hard to provide assistance to the students in the program.
