




This chart shows the total general purpose revenue Millennium High School expects to receive in the coming year from all sources.

The text description for the above chart is as follows: The total revenue projected for Millennium High School is \$6,985,713, of which \$5878831 is Local Control Funding Formula (LCFF), \$701544 is other state funds, \$232818 is local funds, and \$172520 is federal funds. Of the \$5878831 in LCFF Funds, \$361185 is generated based on the enrollment of high needs students (foster youth, English learner, and low-income students).


Increased or Improved Services for High Needs Students in the LCAP for the 2023-24 School Year

In 2023-24, Millennium High School is projecting it will receive \$361185 based on the enrollment of foster youth, English learner, and low-income students. Millennium High School has leveled classes and a designated ELD support class to help increase or improve
services for high needs students. Tutoring is also made available before or after school. The counseling department

Plan Summary [2023-24]

General Information

A description of the LEA, its schools, and its students in grades transitional kindergarten-12, as applicable to the LEA.

Millennium High School provides an education option for all students in grades 9-12 who reside within the Tracy Unified School District and elsewhere in California's Central Valley. As a charter school, Millennium High School is a public school of choice available for parents interested in pursuing a unique educational environment for their children. Millennium High provides access to technology as well as supremely competent and qualified instructors as a source of information and learning. Millennium offers opportunities for early college enrollment and a mandatory summer term called Fast Track that provides opportunities for accelerated learning. Parents, students and educators benefit from productive and specialized classroom environments that provide exciting opportunities to learn.

The staff of Millennium High believes in a vision of education where students do not benefit from access alone but from continuous, dynamic interaction between all shareholders of a learning community. Students, staff, parents, and members of the surrounding community all working collaboratively to provide the best possible education for all. A graduate of Millennium High School will be prepared to further their education equipped with skills that will benefit them as lifelong learners. Graduates will be complex thinkers able to analyze information and draw appropriate conclusions. Graduates will be communicators able to present findings, their point of view and share their research in any setting. A Millennium High graduate will be collaborative having spent four years of high school working with other students and teachers to produce the best possible works. After four years, graduates will be self-directed learners having been instructed in the skills needed to set future academic and career goals, apply to colleges and manage their daily lives. Graduates will also become responsible members of the community having spent four years at Millennium High volunteering 200 hours of community service to businesses, charities and social organizations. A graduate of Millennium High School will aspire to great heights, advance toward higher learning and achieve their dreams and goals.

Reflections: Successes

A description of successes and/or progress based on a review of the California School Dashboard (Dashboard) and local data.

During the 2021-22 school year, all juniors enrolled at Millennium High School participated in the Smarter Balanced Summative Assessment in Language Arts, Mathematics, and Science. According to data derived form the California School Dashboard, in English Language Arts, the category assigned to Millennium Charter is "High," with 46.7 points above standard. That equates to 70% of students meeting or exceeding standard. In mathematics, the category assigned to Millennium was "Medium," with 34.2 points below standard. That equates to 43.86% of students meeting or exceeding standard. The graduation rate was in the "Very High" category with 97.7% of students graduating in 2021-22. Suspension rate was "Medium," with 1.6% of students suspended at least one day. English Learner progress was low, with 50% of students making progress toward English proficiency.

Reflections: Identified Need

The mathematics score compared to the English Language Arts scores show a need for improvement in the area of mathematics. The subgroups of Hispanic and Socioeconomically Disadvantaged were in the "Low" and "Medium" categories, indicating a need for better support for these two subgroups. The Hispanic population scored 83.8 points below standard. The socioeconomically disadvantaged subgroup was 54.8 points below standard. To address this disparity, homework help was made available before and after school. The homework support class was led by a math teacher and also offered the opportunity for peer tutoring. The English Language Department at Millennium offers support to English learners both by pushing into classrooms and by providing pull out services for help with projects and homework.

Millennium High School has a school improvement committee (SIC), which consists of board members, administrators, staff, parents, and students. The committee is lead by the two school leaders and meets once a month. The meetings provide opportunities for all stakeholders to listen to updates regarding the action plan goals and provide feedback. The feedback and work on the action plan drive the goals for the LCAP.

A summary of the feedback provided by specific educational partners.

The SIC committee discussed the need for real-time assessment data to track student progress in language arts and mathematics. At the high school level, only the junior class has the opportunity to participate in the Smarter Balanced Summative Assessment. The SIC committee also identified a need to increase student participation across all grade levels and subjects. Observation data indicates the majority of the time, teachers engage in a lecture-type instructional model. More participation and interaction among teachers and students is needed.

A description of the aspects of the LCAP that were influenced by specific input from educational partners.

The assessment goal included in this LCAP was influenced by stakeholder input The implementation of the i-Ready assessment program will be the first step in establishing verifiable data for all grade levels in both mathematics and language arts. The goal involving instruction was also influenced by stakeholder input. All stakeholders would like to see an increase in the active participation of students in the classroom.

The majority of the actions associated with this goal were followed as planned. The only change to the HUB was the time. It is now incorporated in first period for a total of 15 minutes per day. All of the leadership activities planned were not executed; the rallies and spirit weeks were scheduled, however the other activities were not fulfilled. The SOAR process was changed to a Restorative Practice model and now includes a reflective piece and restorative actions.

Due to inflation increases, the amount budgeted for activities and leadership had to be increased. An increase is also reflected in the EL coordinator's budget and salary. Increases in salaries went up by 6%.

The HUB curriculum continues to be an effective way to share announcements, events and information to the student body. The topics vary, but may include discussions surrounding school wide norms, making healthy choices, the dangers of social media, etc. The EL coordinator has established a supportive relationship with the students. They feel comfortable going to the EL room for help and support. The EL coordinator also helps by contacting parents and holding monthly parent support meetings. The 5 Star system provided quantitative data on the number of students participating in the positive reward system. There are a number of student who take part in the virtual store.

HUB will continue to be a part of the daily schedule, it will still be a part of all first period classes. HUB curriculum will be updated and expanded to include topics such as self-assessments, goals, data chats and cultural components. The staff will be involved in providing feedback and ideas on how to expand cultural opportunities throughout the year. Leadership will follow all actions planned in this goal. The restorative practice program will be updated as needed.

Due to inflation and the rising cost of materials, there was a difference between budgeted expenditures and actual expenditures in this goal in terms of printed material and substitutes.

All teachers are using effective teaching strategies in their lessons. The evidence uploaded to the Google Classroom shows the progression the staff has made in utilizing the strategies and making them work for their subject and classes. All finals have a project based component to them.

There is a need for increased professional development opportunities for staff particularly when it comes to implementing accommodations as stated in 504 and IEP plans. Staff will submit a lesson plan twice monthly to the Google Classroom that will include standards implemented, deeper level questioning and will follow a given template.

The HUB homeroom class will benefit all students, including foster youth, English learners, and low-income students by explicitly teaching school norms. It will be an advisement period where teachers can meet with students, especially those who are experiencing difficulties in a particular class and help students develop goals for improvement. The HUB time will also work as a study hall where all students will have the opportunity to seek help from the teacher on various assignments and homework. It will also serve as a tutoring opportunity. The point system benefits all students by holding them accountable for their actions and also allows teachers to reward positive behavior. Effective instructional strategies help support all students, including foster youth, English learners, and low income students. All subgroups benefit from effective teaching.
