

General Information

Introduction: Valley View Charter Prep is authorized by the New Jerusalem Elementary School District. The school was authorized in January 2014 and began serving students in August 2014 with a current ADA of 616. The school operates as an independent study charter program serving K-12 grades in a personalized learning model. The school is governed by the Pacific Charter Institute (a non-profit) Board of Directors, accredited by the Western Association of Schools and Colleges (WASC) and is an active member of California Charter Schools Association and Charter School Development Center.

During the 22-23 academic year, Valley View Charter Prep finishes out the three-year cycle strong in ELA and we are beginning to experience success in mathematics, through our Direct Instruction Intervention Program. In ELA and mathematics, Valley View saw increases in both scores 3-11, with 80% of our K-2 students reaching benchmarks in early literacy.

Based on Dashboard and the review of local performance indicators, Valley View has identified (1.) the continued progress monitoring of academic achievement, (2.) parent engagement, (3.) the refinement of student preparation for college and career readiness, 4.) early literacy 5.) K-9 mathematics.

This year we focused on strategic and intensive intervention for students not yet proficient. As we move towards year II of our intensive intervention model for K-11 students scoring 30% or below in mathematics and ELA, we anticipate that our scores will continue to climb in an upward trajectory for students not yet proficient.

The Director and WASC Coordinator of Valley View Charter Prep (VVCP) have held multiple Parent Action Committee (PAC) meetings with Educational Partners (including parents, pupils, teachers, other school personnel, and other school administrators.) At these meetings, school leadership addressed the description of the LCAP and WASC processes, explained the templates, progress toward meeting annual goals, and discussed future LCAP and WASC goals.

Annually, Valley View Charter Prep surveys all its Educational Partners (including parents, pupils, teachers, other school personnel, and other school administrators.) Most of the questions in the survey are directly aligned to the 8 Basic State Priorities.

Data from the survey and Educational Partners' meetings were reviewed and discussed. High priority status pertaining to student performance, attendance, and school climate and course offerings were taken into account regarding the school's needs and areas for growth. This information was compiled and the district LCAP and WASC plans are written based on these identified needs. Annually, adjustments to the draft LCAP were made and the final plan was provided to the Board of Directors for approval at a regularly scheduled Board meeting in June.

Utilizing surveys and stakeholder meetings aligned to the Basic 8 State priorities has allowed staff, students and parents the opportunity to directly weigh in on the progress monitoring of this year's LCAP plan and the forming of next year's LCAP goals and plan.

The Direct Instruction Intervention Program for K-12 scholars is something VVCP piloted this year, and based on the data from our latest LCAP survey, VVCP families are seeing great benefits to students and would like for the program to continue for students not yet proficient in mathematics and/or writing.

Valley View scholars have consistently scored well in ELA; however, scores have become stagnant in growth, and math scores are below 50% proficiency. Through AB 130, Direct Instruction Intervention Program, and PLC work, teachers provided 1:4 individualized instruction to students who scored 25% or below on their fall and winter mathematics benchmark assessments. VVCP will expand our AB 130 program to include ELA next year. VVCP will again choose learners whose scores are in the 25% or below and provide intensive intervention to learners Kindergarten through nine and grades ten through twelve.

We have increased our community college outreach as well as our community college visits and tours, and the adoption of Naviance. a computer program that guides students and staff through the process of college and career readiness.

We had a slight increase of 2%. There is an increase in students who are either dually enrolled or applying to a four-year university. It is important to note that the number of students who have applied and been accepted to four-year universities has increased by more than half.

Goal Analysis [2022-23]

An analysis of how this goal was carried out in the previous year. A description of any substantive differences in planned actions and actual implementation of these actions.

A comprehensive assessment strategy was implemented for all students in kindergarten through 2nd grade, consisting of three assessment periods throughout the academic year: fall, winter, and spring. Following the fall and winter assessments, students who did not meet the established benchmarks were promptly enrolled in intervention services and subjected to bi-monthly progress monitoring.

The intervention services provided to these students were diverse and designed to cater to their individual needs. These services included tutoring sessions, dedicated support from credentialed teachers, parent training initiatives, and access to educational platforms such as Lexia, Reading Eggs, Learning Ally, SONDAY and K-2 four on the fence intervention. Each intervention was selected based on its appropriateness and potential effectiveness in addressing the specific areas of difficulty identified in each student's assessment results.

The implementation of such a multifaceted intervention approach demonstrates a proactive and comprehensive strategy to support struggling students. By offering a range of targeted interventions, the program aimed to address various aspects of literacy development, including reading, phonics, comprehension, and parental involvement.

Furthermore, progress monitoring was conducted twice per month, allowing for regular and frequent assessment of student progress. This enabled educators to closely monitor the effectiveness of the interventions and make timely adjustments if needed. The emphasis on progress monitoring reflects a commitment to data-driven decision-making, ensuring that interventions were continually tailored to best meet the students' evolving needs.

In summary, the assessment strategy employed for kindergarten through 2nd grade students included regular assessments throughout the academic year, followed by the provision of intervention services and bi-monthly progress monitoring for students who did not meet benchmarks. The intervention services encompassed various forms of support and educational resources, all carefully selected to address the specific areas of difficulty identified in each student. This comprehensive approach, coupled with frequent progress monitoring, exemplifies a proactive and data-informed effort to support student growth and achievement.

The effectiveness of the specific actions taken can be evaluated based on the achievement of the goal. In this case, since the second-grade cohort successfully met the established goal, it can be concluded that each action implemented was effective.

The intervention services mentioned earlier were tailored to meet the individual goals and academic needs of each student, as determined by the credentialed teacher. This customization and flexibility are core strengths of the program, as it allows for the creation of unique plans for every student. Consequently, if a student encountered difficulties in meeting progress monitoring goals, the teacher would promptly adapt and modify the prescribed intervention to align it more closely with the student's specific needs.

By continuously adjusting the interventions to better suit each student, the teachers demonstrated a proactive and responsive approach to addressing individual challenges. This personalized approach, coupled with ongoing monitoring and adjustment, enhanced the effectiveness of the interventions, ultimately leading to the achievement of the overall goal by the second-grade cohort.

In summary, the effectiveness of the specific actions can be confirmed by the attainment of the goal. The program's ability to customize intervention plans for each student and adapt them as needed showcases the dedication of the teachers in meeting individual needs. By employing a tailored approach, the teachers ensured that interventions were aligned with student requirements, resulting in successful progress towards the stated goal.

Upon a thorough reflection on prior practice, no changes have been made to the planned goal, metrics, desired outcomes; however, actions for the coming year will be an intensive, small cohort intervention group that will consist of small cohorts of 4 or less will meet for forty-five minutes, two to four days a week to attend direct instruction intervention courses by an effective teacher. VVCP will continue to increase its coaching of parent educators and implement progress monitoring to assess student performance and identify areas of improvement. In addition, locally identified interventions will be employed to address specific needs and support student progress.

Recognizing the importance of ongoing professional development, teachers will participate in relevant training opportunities to refine their intervention strategies and enhance their ability to monitor student progress effectively. This commitment to continuous improvement ensures that educators are equipped with the necessary skills and knowledge to provide high-quality interventions tailored to the individual needs of students.

By maintaining consistency in the established goal, metrics, desired outcomes, and actions, the organization is demonstrating a confidence in the efficacy of its existing practices. This approach acknowledges the value of prior experience and affirms the belief that the current strategies and interventions are effective in fostering student growth and achievement. LCFF Carryover Table

- 10. Total Percentage to Increase or Improve Services for the Current School Year (6 divided by 9 + Carryover %)
 - This percentage is the Estimated Actual LCFF Supplemental and/or Concentration Grants (6) divided by the Estimated Actual LCFF Base Grant (9) plus the LCFF Carryover Percentage from the prior year.
- 11. Estimated Actual Percentage of Increased or Improved Services (7 divided by 9, plus 8)
 - This percentage is the Total Estimated Actual Expenditures for Contributing Actions (7) divided by the LCFF Funding (9), then converting the quotient to a percentage and adding the Total Estimated Actual Percentage of Improved Services (8).
- 12. LCFF Carryover Dollar Amount LCFF Carryover (Subtract 11 from 10 and multiply by 9)
